3. The retired Government servant initially engaged on contractual basis for period of one year and further extension is subject to satisfactory performance.
4. He/ She must produce medical fitness certificate from the registered Medical Officer, Government of Odisha.
5. The retired government servant against whom any vigilance case or departmental proceeding or criminal prosecution is contemplated or pending or who has been penalized for misconduct during the period up to five years preceding his / her retirement, or is a member of a political party will not be eligible for Consideration.
6. The engagement of retired Government Servant shall be governed by the provisions of Odisha Government Servants' Conduct Rules, 1959 and shall be liable to be proceeded against for his/ her misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
